Inauguration and key address by the Director (Res.) DoPT, Ministry of Personnel, Public Grievances and Pensions, Govt. of India.

The Constitution Bench of the Supreme Court, in the case of R.K. Sabharwal Vs State of Punjab, as well as, J.C. Mullick Vs Ministry of Railways had held that the reservation of jobs for the backward classes i.e., SC/ST/OBC should apply to posts and not to vacancies hereafter. Accordingly, post-based rosters were introduced by Department of Personnel & Training (DoPT), Ministry of Personnel, Public Grievances and Pensions, Govt. of India vide O.M. No. 36012/2/96, Estt. (Res.) Dated July 02, 1997.

- 2. The outcomes of a considerable long period of 11 years of implementation of these orders are not very encouraging in terms of the realization of targetted goals. It would, however, be worthwhile and relevant to deliberate on various issues and major challenges that are faced by the appointing authorities. In view of this, the Institute which has been pioneer in the field of disseminating the information about post-based rosters (PBR), has now planned Residential Training for the Liaison Officers on Reservation Policy of Govt. of India for SCs/STs and OBCs from February 26 to 28, 2009 at Golden Landmark Hotel, No. 20, Seshadri Road, Bangalore 560 009. (Tel No:080-22284600).
- 3. The main objective of this Training Programme is two fold. One is to assess the extent of successful implementation of the instructions by the appointing authorities and recruiting agencies so as to identify the major obstacles in implementing the instructions; and, the other is to evolve strategies for smooth and proper implementation of these instructions. The deliberations would largely focus on issues pertaining to vertical reservation (for SCs, STs and OBCs) and horizontal reservation (for Persons with Disabilities and Ex-servicemen). The Programme is attached herewith (Annexure-I).

- 4. The Residential Training Programme is aimed at dissemination and propagation of the latest operatives including backlog of OBC posts in nutshell by which the Chief Liaison Officers / Liaison Officers for SCs/STs/OBCs and the concerned staff and others will be greatly benefited whereby grievances / complaints of the SC/ST/OBC Unions / Employees may be reduced to minimum.
- 5. This Residential Training Programme is being organized for Chief Liaison Officers, Liaison Officers, Officials dealing with SC/ST/ and OBC matters.
- 6. The Director (Res.), DoPT, Govt. of India who issues the orders in this regard, will deliver key address and clarify the doubts on spot. A rare opportunity to interacting with the appropriate authority for which your officers have been looking for years.
- You are, therefore, requested to kindly send in your nominations of your 7. delegates along with a DD of Rs.17,415/- (Rs.15,500/- + Service Tax @ 12.36% =Rs.1,915/-) per head towards this Residential programme which covers the cost of Lodging and Boarding, Lunch, Stationery, Study material and Service Tax payable to the Govt. One Room will be shared by two participants. If single room is required, the fee will be Rs.21,348/- inclusive of Service Tax for participant only. Accommodation will be provided from February 25, 2009 (afternoon) to March 01, 2009 (morning). If accommodation is required before and after this, the participant will be required to pay an additional amount of Rs.3,000/- per day. Participant who intends to bring his / her spouse will be required to pay an additional amount of Rs.8,000/-(Rs.4,000/- for those opting for single room) at the time of check-in at the hotel towards the lodging and boarding. Non-Resident participant will be required to pay Rs.10,112/-(Rs.9,000/- + service tax @ 12.36% i.e. Rs.1,112/-). The DD should be drawn in favour of 'Institute of Public Administration', payable at Bangalore and should be sent along with the nomination letter.
